What experience do you have in strategic planning?

What experience do you have in the area of finance?

I have successfully run the above mentioned businesses and entities, all of which required budgeting and fiscal management. I successfully started and grew my chiropractic business, beginning with only \$1000.00 and have sustained the business for 33 years.

What experience do you have in developing procedures?

I learned that constant communication is a must.

I want to serve as a District leader because it is the next step in my contribution to Toastmasters. I know that I can do a great job. Having this confidence in my skills as a leader coupled with all that Toastmasters has done for me, I feel a sense of duty to move forward in the leadership of our District. Also, I know that my skill set will be greatly enhanced through this process. I look at it as learning by doing. Over time I have watched as other people have taken on these jobs. The growth that I've seen has always inspired me. I want to have that in my life.
